

## 2024-2025 LIMITED External Schools of Choice Guidelines MIDDLE SCHOOL

<u>Limited Grades 6<sup>th</sup> – 8<sup>th</sup></u> (70 seats total) May 1 – May 30, 2024 Applications must be received by 3:00 p.m. on May 30, 2024

- 1. Must be a resident of Macomb County.
- 2. Applications will only be accepted during the above approved dates.
- 3. Siblings of students who are currently enrolled in L'Anse Creuse through schools of choice will be given priority to attend, based on available space.
- 4. Once students are accepted, they can remain in L'Anse Creuse until they graduate.
- 5. Applicant students who have been suspended or ever expelled within the last 2 years will be excluded.
- 6. Transportation is the responsibility of the family. All students will need transportation no later than 15 minutes beyond the end of the school day.

### ITEMS TO BE SUBMITTED

All items that apply MUST be submitted with the application. Incomplete packets will not be accepted.

- External School of Choice Application (separate application for each child) COMPLETED Request for Discipline Records form signed by parent/guardian and signed by current school administrator along with PowerSchool log entries (even if blank) or other print-out of student behavior for the previous 2 years. □ *Two* proof of residency: Proof of home ownership: Mortgage Statement or current property tax statement or lease with parent's name listed on lease\*. \* If parent's name is not on the lease, must have a completed Statement of Landlord
  - signed by apartment manager with parent and student name listed. (Parent's name must match student's birth certificate - additional documentation may be required, i.e. marriage license or divorce decree)

#### AND

- Any one item listed (MUST be current and dated within 30 days of application) Utility bill, cell phone bill, current automobile loan or lease, insurance statement or bank statement. (Shutoff notices will not be accepted)
- Child's most current IEP if your child is presently receiving any special services (i.e., special education, speech)
