

## 2025-2026 <u>External</u> Schools of Choice Guidelines <u>ELEMENTARY</u>

<u>Unlimited Grades Kindergarten – 5th</u>

**February 4 – August 21, 2025** 

(Completed Applications must be received by 12:00 p.m. on August 21, 2025

- 1. Must be a resident of Macomb County.
- 2. Applications will only be accepted during the above approved dates.
- 3. Siblings of students who are currently enrolled in L'Anse Creuse through schools of choice will be given priority to attend, based on available space.
- 4. Once students are accepted, they can remain in L'Anse Creuse until they graduate.
- 5. Applicant students who have been suspended or ever expelled within the last 2 years will be excluded.
- 6. Transportation is the responsibility of the family. All students will need transportation no later than 15 minutes beyond the end of the school day.

All items that apply MUST be submitted with the application. Incomplete packets will not be accepted.
