

2024-2025 External Schools of Choice Guidelines

<u>Unlimited Kindergarten – 5th Grade</u> February 8 – August 30, 2024

(Complete Applications must be received by 12:00 p.m. on Aug. 30, 2024)

- 1. Must be a resident of Macomb County.
- 2. Applications will only be accepted during the above approved dates.
- 3. Siblings of students who are currently enrolled in L'Anse Creuse through schools of choice will be given priority to attend, based on available space.
- 4. Once students are accepted, they can remain in L'Anse Creuse until they graduate.
- 5. Applicant students who have been suspended or ever expelled within the last 2 years will be excluded.
- 6. Transportation is the responsibility of the family. All students will need transportation no later than 15 minutes beyond the end of the school day.

	Any one item listed (MUST be current and dated within 30 days of registration) Utility bill, cell phone bill, current automobile loan/lease, insurance statement or bank statement.
	Most current IEP if your child is presently receiving any special services (i.e., special education, speech)
	Kindergarten students must complete Kindergarten Selection Form
